- 4. The Members, at Serial No. (q) and (r), shall be appointed for a period of three years, which may be extended for a further period of one year, unless they resign earlier or removed from holding such office due to disqualification or ineligibility, as the case may be.
- 5. The Members, at Serial No. (q) and (r), may be paid an honoraria as approved by the Board.
