No.PS/SLG&RDD/Misc/2014. WHEREAS the Government of Khyber Pakhtunkhwa is committed to open, transparent and fair competition in award of contracts for works, services and procurement of goods;

AND WHEREAS the Government of Khyber Pakhtunkhwa has decided to adopt E-Tendering as a system for award of contracts to ensure transparency and fairness.

AND WHEREAS District Councils, Municipal Committees and Local Area Development Authorities in the Province are executing agencies of contracts for works, services and procurements from local and provincial resources;

AND WHEREAS there are reports of irregularities in award of contracts in Local Councils and Local Area Development Authorities.

NOW THEREFORE; the Government of Khyber Pakhtunkhwa in Local Government and Rural Development Department hereby directs that henceforth all Local Councils and Local Area Development Authorities in the province of Khyber Pakhtunkhwa shall offer their contracts through E-Tendering System.

Any Contract, Quotation, Tender or Offer for works, services and procurement of goods made by any Local Council or Local Area Development Authority without posting on their Website shall be void and shall be deemed as omission and commission entailing major penalty in terms of efficiency and discipline rules applicable to the respective institution.

This Notification shall be applicable with immediate effect.
