Dated Peshawar, the 26th February, 2015.

No. PA/Khyber Pakhtunkhwa/Bills/2015/4940.—The Khyber Pakhtunkhwa Local Government (Second Amendment) Bill, 2015 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 17<sup>th</sup> February, 2015 and assented to by the Governor of the Khyber Pakhtunkhwa on 24<sup>th</sup> February, 2015 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

### THE KHYBER PAKHTUNKHWA LOCAL GOVERNMENT (SECOND AMENDMENT) ACT, 2015

(KHYBER PAKHTUNKHWA ACT NO. XI OF 2015)

*(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 26<sup>th</sup> February, 2015).*

*further to amend the Khyber Pakhtunkhwa  
Local Government Act, 2013.*

**WHEREAS** it is expedient further to amend the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013) for the purpose hereinafter appearing;

It is hereby enacted as follows:-

- 1. Short title and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa Local Government (Second Amendment) Act, 2015.



(2) It shall come into force at once.

2. **Amendment of section 2 of the Khyber Pakhtunkhwa Act No. XXVIII of 2013.**--- In the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), hereinafter referred to as the said Act, in section 2, the existing clause (a), shall be re-numbered as clause (aa) of section 2 and before clause (aa), as so re-numbered, the following new clause shall be inserted, namely:

“(a) “biometric” means the measurement and analysis of unique physical characteristics such as fingerprints for verifying and authenticating the personal identity of a voter;”.

3. **Amendment of section 6 of the Khyber Pakhtunkhwa Act No. XXVIII of 2013.**---In the said Act, in section 6, in sub-section (2), in clause (e) of the first proviso, the colon appearing at the end shall be replaced by a full stop and thereafter the second proviso shall be deleted.

4. **Substitution of section 26 of the Khyber Pakhtunkhwa Act No. XXVIII of 2013.**--- In the said Act, for section 26, the following shall be substituted, namely:

“26. **Establishment of Village Council and Neighbourhood Council.**---After delimitation of Village Council and Neighbourhood Council by Election Commission of Pakistan, Government shall by notification in the official Gazette, notify Village Council and Neighbourhood Council in all districts.”.

5. **Amendment of section 27 of the Khyber Pakhtunkhwa Act No. XXVIII of 2013.**--- In the said Act, in section 27, in sub-section (3), the full stop appearing at the end shall be replaced by a colon and thereafter, the following proviso shall be added, namely:

“Provided that if the required number of general members of Village Council or Neighborhood Council have been elected unopposed, the election of Nazim and Naib Nazim of Village Council or Neighborhood Council, as the case may be, shall be conducted in the manner as provided in section 79.”

6. **Insertion of new section 77A to the Khyber Pakhtunkhwa Act No. XXVIII of 2013.**---In the said Act, after section 77, the following new section shall be inserted, namely:

“77A. **Identification of voter.**---The identity of a voter at a polling station shall be confirmed and satisfied by the concerned authorities by using biometrics machine specified and provided by the Election Commission:

Provided that where no biometric machine is provided by the Election Commission, the identity of a voter shall be confirmed and satisfied by the concerned authority by using normal procedure of identification.”

7. **Amendment of the SECOND SCHEDULE to the Khyber Pakhtunkhwa Act No. XXVIII of 2013.**---In the said Act, in SECOND SCHEDULE,-



(a) in Part-A,-

(i) in the columns against District "**Kohistan**", for the existing entries, the following shall be substituted, in respective columns, namely:

*to amend the Khyber Pakhtunkhwa  
Local Government Act, 2013.*

WHEREAS it is expedient to amend the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), for the purposes hereinafter appearing;

It is hereby enacted as follows:

- 1. Short title and commencement.**—(1) This Act may be called the Khyber Pakhtunkhwa Local Government (Amendment) Act, 2014.



(2) It shall come into force at once.

2. **Amendment of the SECOND SCHEDULE to the Khyber Pakhtunkhwa Act No. XXVIII of 2013.**---In the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), in SECOND SCHEDULE,-

(a) In Part-A,-

(i) in the columns against the District Dir Upper, for the existing entries, the following shall be substituted, in respective columns, namely:

"Dir Upper	32	10	2	2	2	48"; and

(ii) in the columns against the District Torghar for existing entries, the following shall be substituted, in respective columns, namely:

"Torghar	16	5	1	1	1	24"; and

(b) In Part-B,-

(i) for the existing entries occurring against the Tehsil "Nowshera", the following shall be substituted, namely:
