# THE KHYBER PAKHTUNKHWA LOCAL GOVERNMENT (SIXTH AMENDMENT) ACT, 2015

#### (KHYBER PAKHTUNKHWA ACT NO. XLI OF 2015)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa.

(Extraordinary), dated the 9/12/2015)

AN ACT

further to amend the Khyber Pakhtunkhwa Local Government Act, 2013.

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), for the purpose hereinafter appearing;

It is hereby enacted as follows:

1. Short title and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa Local Government (Sixth Amendment) Act, 2015.

- (2) It shall come into force at once.
- 2. Amendment of section 84 of the Khyber Pakhtunkhwa Act No. XXVIII 2013.—In the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), the existing section 84 shall be re-numbered as sub-section (1) of section 84 and after sub-section (1), as so renumbered, the following new sub-section shall be added, namely:
  - "(2) Subject to this Act, in case a Nazim or Naib Nazim, District Government or Tehsil or Town Nazim or Naib Nazim fails to approve the budget of a District Council or the Tehsil or Town Council, as the case may be, not less than twenty per cent of the members of the concerned Council shall place requisition before the Council asking the concerned Nazim or Naib Nazim to seek fresh vote of confidence from the Council concerned and if, he fails to get the vote of confidence, then the Nazim or Naib Nazim shall cease to hold the office."
