further to amend the Khyber Pakhtunkhwa Local Government Act, 2013

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Government Local Act, 2013 (Khyber Pakhtunkhwa Act, No. XXVIII of 2013), for the purposes hereinafter appearing;

It is hereby enacted as follows:

1. **Short title and commencement.**— (1) This Act may be called the Khyber Pakhtunkhwa Local Government (Amendment) Act, 2017.

(2) It shall come into force at once except paragraph (b) of clause 4 of the Act which shall come into force on the announcement of the next Local Government Election.

2. **Insertion of new section in the Khyber Pakhtunkhwa Act No. XXVIII of 2013.**--- In the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), hereinafter referred to as the said Act, after section 17, the following new section shall be inserted, namely:

"17-A. Secretariat of the Council.--- The District Council shall have its Secretariat under the Naib Nazim and shall have a separate budget allocation within the allocated budget of the District Council with its Secretary as Drawing and Disbursing Officer and Naib Nazim as the Principal Accounting Officer. "

3. **Amendment of section 27 of the Khyber Pakhtunkhwa Act No. XXVIII of 2013.**--- In the said Act, in section 27, after sub-section (1), the following new sub-section, shall be inserted, namely:

"(1A) Notwithstanding anything contained in sub-section (1), in a village council or neighbourhood council, as the case may be, where non-muslim voters do not exist in the electoral rolls of such village council or neighbourhood council, such council shall be deemed to be properly constituted without election to seats reserved for non-muslims."

4. **Amendment of the Second Schedule to the Khyber Pakhtunkhwa Act No. XXVIII of 2013.**--- In the said Act, in the Second Schedule, in Part-B,-

(a) for the existing entries occurring against the Tehsil "Alpuri", the following shall be substituted, namely:

"Alpuri	14	5	1	1	1	22"; and

(b) after Tehsil "Alpuri", as so emended, the following new entries shall be inserted, in respective columns, namely:
