- 3- Only technical Bids will be opened on date of tender opening in the presence of interested bidders, while financial bids of technically qualified bidders will be opened on a date to be intimated later on.
- 4- 02% earnest money in the shape of Call Deposit/Bank draft in the name of Chief Executive Officer, Water & Sanitation Services company Bannu will be submitted along with Financial Bid (Copy of Earnest money/Bank draft after deleting amount should be attached with Technical Bid).
- 5- All applicable taxes including GST, Sale Tax, Income Tax, KPRA Taxes etc as per Government Rules, shall be included in offered prices.
- 6- All the rates shall be quoted on Freight on Residents (F.O.R) basis with free supply to the destination at WSSC Bannu.
- 7- The bidder should bear transportation and accommodation charges of three to five members of inspection team of WSSC, Bannu at Manufacturer site before delivery.
- 8- Bidder shall provide complete literature, specification, drawings along with proof of supply of such items to other customers in their Technical bid.
- 9- Successful bidder shall provide complete operational training to the user department free of cost at the time of supply of machinery equipment's.
- 10- Bidder must quote for complete lots mentioned in tender, the bid of only those bidders shall be consider who quoted rates for all lots.
- 11- Pre bid meeting will be held on 27 /07/2020 at 11:00AM at the Office of CEO WSSC Bannu.
- 12- Incomplete, conditional, or telegraphic tenders shall not be entertained.
- 13- The competent authority reserves the right to accept or reject any or all tenders with cogent reason as per KPPRA Rules.
- 14- The valid authority letter of chassis assembler and manufacturer is mandatory required.
- 15- The number of Machinery/Equipment can be increase or decrease as per the company requirements.
