

NOTIFICATION

Peshawar, dated the 07th November, 2022

No. CU(LGE&RDD)/Allowances/2022. In exercise of the powers conferred by Section 112 of the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), read with Part-I of Seventh Schedule thereof, the Government of Khyber Pakhtunkhwa is pleased to make the following rules, namely:

THE KHYBER PAKHTUNKHWA LOCAL GOVERNMENT ELECTED OFFICIALS REMUNERATION AND ALLOWANCES RULES, 2022

Part-I

General

1. **Short title and commencement.**---(1) These rules may be called the Khyber Pakhtunkhwa Local Government Elected Officials Remuneration and Allowances Rules, 2022.

(2) These rules shall come into force on such date as the Department may appointed.

2. **Definitions.**--- (1) In these rules, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them, that is to say,-

- (a) **“Act”** means the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013);
- (b) **“allowance”** means a sum of money paid to the chairman, presiding officer or member of the concerned council.
- (c) **“business”** means all work, done by the Tehsil Council, village council or neighbourhood council, as the case maybe, in pursuance of the Act or any rules or bye-laws made thereunder;
- (d) **“Chairman”** means the chairman of the Tehsil Local Government, village council or, as the case may be, neighbourhood council;
- (e) **“committee”** means a committee, constituted for the purposes of section 25 and 29 of the Act and includes a special committee, appointed by the tehsil council, village council or, as the case may be, neighbourhood council;
- (f) **“elected official”** means Mayor, Chairman, member and Presiding Officer Tehsil Council and Chairman and member of the village council or neighbourhood council;
- (g) **“member”** means a member of the City Council/ Tehsil Council, village council or neighbourhood council, as the case may be;
- (h) **“Mayor”** means the Mayor of the City Local Government and includes Metropolitan City Local Government, Peshawar, notified under the Act;
- (i) **“neighbourhood council”** means a neighbourhood council constituted under the Act;
- (j) **“Presiding Officer”** means one of the members, elected by the Tehsil Council, who presides over the meetings of the Tehsil Council;
- (k) **“remuneration”** means a sum of money, paid to the elected officials of the Province;
- (l) **“Secretary”** means the secretary of Tehsil Council, village council or neighbourhood, as the case may be, and includes any person for the time being performing duties of the secretary;

- (m) "session" means the period commencing the day on which the City Council / Tehsil Council, village council or neighbourhood council, as the case may be, first meets after having been summoned and ending the day on which the council is prorogued;
- (n) "sitting" means the meeting of the City Council / Tehsil Council, Village Council or, as the case may be, Neighbourhood Council or any of its committees from the commencement of its business to the termination of the business for the day;
- (o) "Tehsil Council" means Tehsil Council constituted under the Act; and
- (p) "village council" means a village council constituted under the Act;

(2) Words or expressions, used but not defined in these rules, shall have the same meanings as are respectively assigned to them in the Act.

Part-II

Remuneration and Allowances

3. Remuneration and Allowances for Mayor, Chairman, Presiding Officer and Member City Council / Tehsil Council.---(1) The rates of remuneration and allowances for the Mayor, Chairman, member and Presiding Officer City Council or Tehsil Council, as the case may be, shall be as under;

(2) The remuneration and allowances shall not be paid for the period during which the Mayor, Chairman or member, as the case may be, was under detention on conviction for an offence, involving moral turpitude under any law for the time being in force.

(3) The remuneration and allowances shall not be paid for the period during which the Mayor, Chairman or member, as the case may be, is on leave for a period of more than forty (40) days.

(4) The Secretary of the City Council / Tehsil Council shall authenticate the attendance register and ancillary record of the remuneration and allowances.

4. Remuneration and Allowances for Chairman and member village council and neighbourhood council.---(1) The rates of remuneration and allowances for the Chairman and members village council or neighbourhood council, as the case may be, shall be as under;

(2) The remuneration and allowances shall not be paid for the period during which the Chairman or member of village council or neighbourhood council was under detention on conviction for an offence involving moral turpitude under any law for the time being in force.

(3) The remuneration and allowances shall not be paid for the period during which the Chairman or member of village council or neighbourhood council, as the case may be, is on leave for a period of more than forty (40) days.

(4) The Secretary of the village council or neighbourhood council shall authenticate the attendance register and ancillary record of the remuneration and allowances.

5. Application of remuneration and allowances. --- (1) The remuneration and allowances shall be allowed from the date of notification of assumption of office by the Mayor, Chairman and member City Council/Tehsil Council and Chairman and member of village council or neighbourhood council.

(2) Government may, from time to time, as it may deem appropriate, revise the rate of remuneration and allowances.

6. Repeal. --- All previous notifications, order, instructions etc. issued before the commencement of these rules, shall be deemed to have been repealed.
