No. \_\_\_\_\_\_.--In exercise of the powers conferred by section 113 of the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), read with Part-II of Seventh Schedule thereof, the Government of Khyber Pakhtunkhwa is pleased to make the following bye-laws, namely:

## THE TEHSIL COUNCIL (PROCEDURE FOR CONDUCT OF BUSINESS AND MEETINGS) BYE-LAWS, 2022.

#### <u>Chapter-I</u> Preliminary

- 1. Short title and commencement.---(1) These bye-laws may be called the Tehsil Council \_\_\_\_\_\_ (Procedure for Conduct of Business and Meetings) Bye-Laws, 2022.
  - (2) These bye-laws shall come into force at once.
- 2. **Definitions.**—(1) In these bye-laws, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them, that is to say,—
  - (a) "Act" means the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013);
  - (b) "budget" means the statement laid before the Tehsil Council under section 35 of the Act;
  - (c) "Chairman" means the Chairman, Tehsil Local Government and includes the person for the time being performing the duties of the Chairman, which shall be read as Mayor, City Local Government and City Local Council and Mayor, Capital Metropolitan Government Peshawar;
  - (d) "Committee" means a Committee, constituted for the purposes of clause (h) of section 25 of the Act, and includes a special committee by the Tehsil Council;
  - (e) "Convener" means the Chairman of the Tehsil Local Government who convene meeting of the Tehsil Council;
  - (f) "Leader of the opposition" means the member, who is, for the time being, the leader in the Tehsil Council of the largest party or coalition of parties in opposition;

- (h) "member" means a member of the Tehsil Council;
- (i) "member-in-charge" means, in the case of official business, any member, acting on behalf of the Chairman, and in case of any other business, the member who has introduced it or any other member authorized by him in writing to assume charge of the business in his absence;
- (j) "motion" means a proposal, made by a member, relating to any matter, which may be discussed by the Tehsil Council and includes a resolution and an amendment;
- (k) "Presiding Officer" means the member of Tehsil Council, duly elected by the Tehsil Council, to preside over the meetings of the Tehsil Council, and during temporary absence of the Chairman deputize him as Chairman under sub-clause (i) of sub-section (1) of section 25 of the Act;
- (l) "private member" means a member of the Tehsil Council, who is not acting on behalf of the Chairman;
- (m) "Schedule" means a Schedule appended to these bye-laws;
- (n) "Secretary" means the Secretary of the Tehsil Council and includes any person for the time being performing the duties of the Secretary;
- (o) "session" means the period, commencing the day on which the Tehsil Council first meets, after having been summoned and ending the day on which the Tehsil Council is prorogued;
- (p) "sitting" means the meeting of the Tehsil Council or any of its Committees from the commencement of its business to the termination of the business for the day;
- (q) "starred question" means a question for an oral answer; and
- (r) "un-starred question" means a question for a written answer.
- (2) Words or expressions, used but not defined in these bye-laws, shall have the same meanings as are assigned to them in the Act or, as the case may be, the rules.

#### <u>Chapter-II</u> Convening, Adjournment and Prorogation

3. Convening of the Tehsil Council.---When the Tehsil Council is convened, in pursuance of sub-section (4) of section 79 of the Act, the Secretary shall intimate to each member the date, time and place, fixed by the Chairman for the meeting of the Tehsil Council and shall issue a notification in respect thereof:

Provided that if the Tehsil Council is convened at short notice or in case of an emergency, the Secretary shall also intimate the date, time and place of the meeting to the members through other quick means of communication.

- 4. Adjournment.---Subject to the provisions of the Act, the sitting of the Tehsil Council may be adjourned from time to time by order of the Presiding Officer.
- 5. **Prorogation.---**(1) A session of the Tehsil Council is to be terminated by the order of prorogation, issued by the Secretary, with the approval of the Presiding Officer, through a Notification to that effect.
- (2) On the prorogation of a session, all pending notices and business shall lapse, except the business relating to bye-laws.

#### <u>Chapter-III</u> Seating, Oath and Roll of Members

- 6. Oath, roll and seating of members.---(1) A member shall not sit or vote in the Tehsil Council, until he has made and subscribed to an oath, as required under section 80 of the Act. Before taking his seat, he shall also sign the roll of members.
  - (2) Members shall sit in such order as the Presiding Officer may determine.

#### <u>Chapter-IV</u> The Presiding Officer and Panel of Chairperson

- 7. Powers and functions of the Presiding Officer.---(1) The Presiding Officer shall take the chair at every sitting of the Tehsil Council, at the hour to which the Tehsil Council is adjourned at the last sitting or at the hour, at which the Tehsil Council has been summoned to meet.
  - (2) The Presiding Officer shall-
    - (a) call the sitting to order;
    - (b) preserve order and decorum;
    - (c) have all powers necessary for the purpose of enforcing his decisions;
    - (d) have the power to cause them to be cleared, in case of disturbance or disorder in the galleries;
    - (e) decide all points of order; and
    - (f) have the powers to withdraw his consent already communicated for the presentation of a privilege motion, an adjournment motion or a resolution if some fresh material is furnished to him on account of which he is satisfied that the withdrawal of the consent already granted was necessary to be revoked.

#### <u>Chapter-V</u> <u>Sitting of the Tehsil Council</u>

- 8. Commencement of the sitting.---Every sitting of the Tehsil Council shall commence with a recitation from the Holy Quran.
- 9. Sessions calendar.---The Tehsil Council shall be in Session for thirty-five (35) days in a calendar year and it shall be mandatory for the Tehsil Council to meet at least

once in every month as per session calendar. The Chairman shall allocate days to the monthly meetings for achieving the target days.

- 10. Sitting of the Tehsil Council.---(1) Unless the Presiding Officer otherwise directs, the monthly session of the Tehsil Council shall start on the first working day of the third week of every month.
- (2) During the session, unless otherwise directed by the Presiding Officer, the Tehsil Council shall have at least five business hours starting from 10:00 hours.
- (3) If the business, set down in the list of business for the day, is completed earlier, or if it is not completed in the allocated five hours, the Presiding Officer shall adjourn the session of the Tehsil Council with question put, and the proceeding or any business, under consideration, shall be interrupted:

Provided that-



- (a) if at the time of interruption the closure is moved or proceedings under closure are in progress, the proceedings under the closure shall be completed before the Tehsil Council is adjourned;
- (b) a motion may be made by the Chairman at the commencement of the business for the day to be decided without amendment or debate to the following effect:

"that the proceedings on any specified item or items of business be exempted at this day's sitting from the provisions on interruption". If such a motion is carried, the business so specified, shall not be interrupted.

- 11. Adjournment of sittings.---Subject to other provisions of these bye-laws, the Presiding Officer may-
  - (a) adjourn a sitting of the Tehsil Council; and
  - (b) call a sitting of the Tehsil Council at a time and date different from that to which it was earlier adjourned, if he so thinks fit,.

#### <u>Chapter-VI</u> Arrangement and Transaction of Business

12. Arrangement of business.---(1) The Secretary shall arrange Tehsil Local Government business in such order as the Chairman or in his absence the member-in charge may intimate:

Provided that the Presiding Officer may direct that the bye-laws and resolutions may be taken up on separate days, and on the day when bye-laws are so taken up the first half of the day shall be allowed for bye-laws to be introduced and the later half of the day for bye-laws, if any, which have advanced beyond the stage of introduction.

- (2) Bye-laws which have been introduced shall be arranged in the following order of priority-
  - (a) bye-laws at approval stage;

- (b) bye-laws at consideration stage;
- (c) presentation of report of select committee on bye-laws;
- (d) bye-laws circulated for the purpose of eliciting opinion thereon; and
- (e) bye-laws which have been introduced, but which have not advanced to any of the stages set out above.
- (3) A list of business, under sub-rule (1) for each day, shall be prepared by the Secretary and a copy thereof shall be made available for the use of every member and all Tehsil Officers.
  - (4) Save as otherwise provided in these bye-laws,-



- (a) the business for the day shall be transacted in the order in which it appears in the list for that day;
- (b) no business, not included in the list of business, shall be transacted at any sitting, except business of ceremonial nature permitted by the presiding officer; and
- (c) no business, requiring notice, shall be set down for a day earlier than the day following the day on which the period of the notice necessary for that class of business expires.
- 13. Business outstanding at the end of the day.---All business, appointed for any day and not disposed off before the termination of the sitting, shall stand over until the next day available for such class of business, or until such other day in the session so available, as the member-in-charge of the business may desire.
- 14. Giving of notice by members.---Save as otherwise provided in these bye-laws, every notice, required under the rules, shall be given in writing, addressed to the Secretary and shall be delivered at his office. If it is delivered during office hours on a day when the office is open, it shall be treated as delivered on that day. If it is delivered at any later time or on any holiday, it shall be treated as delivered on the day on which the office next opens. A notice or communication which is not legibly written may, and if it is not signed by the member sending it, shall be rejected.
- 15. Circulation of notice to members.---(1) The Secretary shall circulate to each member and the respective Tehsil Officer a copy of notice or other papers required under these bye-laws to be made available.
- (2) A notice or other papers shall be deemed to have been made available to a member,-
  - (a) if delivered by hand at the address given by him when the Tehsil Council is in session and for two days before the commencement of the session, unless otherwise requested by the member, or if it is placed in the seat allotted to him in the Tehsil Council chambers when the Tehsil Council is sitting; and
  - (b) if sent by post to his permanent address as registered in the office of the Tehsil Council at other times.

#### Chapter-VII Questions

17. Time of questions.---Except as otherwise provided in these bye-laws, the first hour of every sitting, after recitation from the Holy Quran and the swearing in of member, if any, shall be Scheduled as questioning and answering hour.

Provided that there shall be no question hour,-



- (a) on the day the budget is presented;
- (b) on the first day of the session;
- (c) on a day fixed for moving of resolution of no confidence or impeachment of Chairman; and
- (d) on the days fixed for discussion on the budget or for voting on demands for grants relating to the budget.
- 18. Notice of questions.---Not less than four clear days notice of a question shall be given unless the presiding officer, with the consent of the Chairman, allows a question to be asked at shorter notice.
- 19. Short notice questions.---Question, at short notice, shall ordinarily be answered at the termination of the question hour; provided that-
  - (a) a member may not ask more than one short notice question on any one day; and
  - (b) a short notice question may not be asked to anticipate a question of which notice has already been given.
- **20.** Form of notice of questions.---(1) Notice of a question shall be given in writing to the secretary and shall specify the Tehsil Office to which it relates, or if the question is addressed to a member, the name of that member.
- (2) A member, who desires an oral answer to his question, shall distinguish it with an asterisk, however the Presiding Officer may, in his discretion, direct that such question be placed on the list of questions for written answers if he considers that a written reply would be more appropriate.
- 21. Notice of admission of questions.—No question shall be placed on the list of questions for answer until three clear days have expired from the day on which notice of admission of the question by the Presiding Officer was given by the Secretary to the concerned Tehsil Officer.
- 22. Number of questions to be put on any one day.---(1) As deem appropriate by the Presiding Officer, not more than three starred questions and three un-starred questions from the same member shall be placed on the list of questions for any one day.
- (2) The questions shall be put on the list of questions in the order in which their notices are received.

- 23. Allotment of days for questions.---The time for answering questions shall be allotted in rotation on different days for the answering of questions relating to such offices of the Tehsil Local Government, as the Presiding Officer may, from time to time, specify and on such day only questions relating to the office for which time on that day has been allotted, and questions addressed to members, shall be placed on the list of questions for answers.
- 24. Written answers to questions not replied orally.---If any question, placed on the list of questions for answers on any day, is not called for answer within the time available for answering of questions on that day, the answer shall be laid on the table of member-in charge or the member to whom the question is addressed and no oral answer shall be required for such a question nor shall any supplementary question be asked in respect thereof.
- 25. Subject matter of questions.---Subject to the provisions of these bye-laws, a question may be asked for the purpose of obtaining information on a matter of public concern within the special cognizance of the Chairman, or the Tehsil Office or the member to whom it is addressed.
- 26. Matter to which questions shall relate.---(1) A question, addressed to the Chairman, shall relate to the public affairs with which he is officially connected, or to a matter of administration for which he is responsible.
- (2) A question addressed to a member shall relate to some matter connected with the business of the Tehsil Council for which that member is responsible.
- 27. Non-admissible questions.--- A question shall not be admissible if it-
  - is trivial, vexatious, vague or meaningless or contains arguments, inferences, ironical expressions, imputations, epithets or defamatory statements;
  - (b) relates to a matter which is not primarily the concern of Tehsil Local Government;
  - (c) asks for an expression of opinion on a hypothetical proposition;
  - (d) refers to the character or conduct of any person except in his official or public capacity;
  - (e) makes or implies a charge of a personal character;
  - (f) contains any reflection on the conduct of any person or institution beyond the responsibility of Tehsil Local Government; or
  - (g) contains remarks about matters sub-judice in Courts
- 28. Presiding Officer to decide admissibility of questions.---Within two days from the date of receipt of the notice, the Presiding Officer shall decide on the admissibility of a question and shall disallow any question which, in his opinion, contravenes these bye-laws, or he may, in his discretion, amend it in form.
- 29. List of questions.---Subject to paragraphs 18 and 23 of these bye-laws, questions shall be entered in the list of questions for the day along with the answers

thereto which are received in the office of the Secretary, at least one clear day before that day, and shall be called in the order in which they stand in the list, unless the Presiding Officer changes that order with the leave of the Tehsil Council.

- **30.** Mode of asking questions.---(1) At the time of asking question, the Presiding Officer shall call successively each member, in whose name a starred question appears in the list of questions.
- (2) The member, so called, shall stand in his place and unless he states that it is not his intention to ask the question standing in his name, he shall ask the question by reference to its number on the list of questions.
- (3) If on a question, being called, it is not put or the member, in whose name it stands, is absent, the Presiding Officer, at the request of any other member, may direct that the answer to it be given.
- 31. Supplementary questions.---When a starred question has been answered, any member may ask such supplementary questions as may be necessary for elucidation of the answer, but the Presiding Officer shall disallow a supplementary question which, in his opinion, is an abuse of the right of asking questions.
- **32. Prohibition of discussion on question or answer**.---There shall be no discussion on any question or answer, except as provided in paragraph 31.
- 33. Discussion on important matters arising out of answer to a question.---(1) The Presiding Officer may, on one clear day's notice being given by a member, allot one hour for discussion on a matter of public importance which has recently been the subject of a question.
- (2) Such notices shall be considered by the Presiding Officer in the order in which they are received, and when one such notice is admitted all other notices shall lapse.
- (3) The Presiding Officer shall decide whether the matter is of sufficient public importance to be put down for discussion.
- (4) There shall be neither voting nor any motion in the course of or at the conclusion of such discussion.

## <u>Chapter-VIII</u> <u>Leave of Absence, Resignation and</u> Vacation of Seats in the Tehsil Council

- 34. Leave of absence from the Tehsil Council.---(1) A member desirous of obtaining the leave of the Tehsil Council for his absence may make an application in writing addressed to the Presiding Officer, stating reasons for his absence.
- (2) On receipt of an application under sub-paragraph (1), the Presiding Officer shall immediately after the questions hour, if any, but before any other business for the day is entered upon put the question without debate, that leave be granted.
- (3) Where a member is prevented or incapacitated from making such an application, leave of the Tehsil Council may be granted on an application made by any other member on his behalf.

- (4) The Secretary shall, as soon as possible, communicate the decision of the Tehsil Council to the member concerned.
- 35. Resignation of seat.---(1) When a member resigns his seat under section 82 of the Act, the Chairman shall, as soon as may be, after he has received an intimation in writing from a member, inform the Tehsil Council of the resignation:

Provided that when the Tehsil Council is not in session, the Presiding Officer shall inform the Tehsil Council immediately after it reassembles that such member has resigned his seat in the Tehsil Council.

- (2) The Secretary shall, as soon as may be after the Chairman has received intimation from a member resigning his seat in the Tehsil Council, issue a notification to the effect that the member has resigned his seat and forward a copy of the notification to the Election Commission of Pakistan for taking steps to fill the vacancy thus caused. A copy of such notification shall also be forwarded to Government and Tehsil Local Government for information and necessary action.
- 36. Seat becoming vacant.---(1) If a member is absent, without leave or reasonable cause from three consecutive meetings of the Tehsil Council, the Presiding Officer with the consent of Chairman shall bring the fact to the notice of the Tehsil Council and there upon any member may move that the seat of the member who has been so absent, be declared vacant.
- (2) If the seat of the member is declared vacant, the Secretary shall issue a notification to that effect and forward a copy of the notification to the Election Commission of Pakistan for decision.
- 37. Attendance and minutes register.—The Secretary shall cause a register to be kept showing the attendance of each member at each sitting and recording of minutes of the session, and shall make the register available for inspection by the members.

### Chapter-IX Call Attention Notice

- 38. Procedure regarding call attention notice.—A member may, with permission of the Presiding Officer, call the attention of the Chairman to any matter of urgent importance and the Chairman may make a brief statement or ask for time to make a statement during the same or next sitting.
- 39. No debate on the statement.---There shall be no debate on such statement at the time it is made but each member, in whose name the item stands in the list of business, may, with permission of Presiding Officer, ask a question.
- 40. Member giving notice.--- Where a notice is signed by more than one member, it shall be deemed to have been given by the first signatory only and in his absence, the next signatory and so on.
- 41. Precedence of notices.---Notices for a sitting, received not later than one hour the time fixed for the sitting, shall be deemed to have been received for the sitting on that day and notices, received later than one hour before the time fixed for the sitting, shall be deemed to have been given for the next sitting.
- 42. Restriction on raising matters.---Not more than two such matters shall be raised at the same sitting.

- 43. Priority of the matter.---In the event of more than one matter being presented for the same day, priority shall be given to the matter which is, in the opinion of the Presiding Officer, more urgent and important.
- 44. Notices to lapse.---All notices which have not been taken up at the sitting for which they have been given shall lapse at the end of the sitting.

#### <u>Chapter-X</u> Question of Privileges

- 45. Question of privilege.---A member may, with prior approval of the Presiding Officer, raise a question involving a breach of privilege either of a member or of the Presiding Officer or of the Tehsil Council or of a committee thereof.
- 46. Notice of question of privilege.--- A Member, wishing to raise a question of privilege, shall give notice, in writing, to the Secretary before the commencement of the sitting on the day the question is proposed to be raised.
- 47. Condition for admissibility of question of privilege.---The right to raise a question of privilege shall be governed by following conditions:
  - (a) not more than one question shall be raised by the same member at the same sitting regarding the same subject matter;
  - (b) the question shall relate to a specific matter of recent occurrence;
  - (c) the matter shall be such as requires intervention of the Tehsil Council.
- 48. Mode of raising a question of privilege.—The Presiding Officer shall, after the disposal of questions and before the list of business is entered upon, call upon the member who gave the notice and thereupon the member shall raise the question of privilege and make a short statement relevant thereto.
- 49. Consideration by the Tehsil Council or reference to the Committee on privileges.—If the Presiding Officer holds the motion to be in order, the Tehsil Council may consider and decide a question of privilege or may, on a motion either by the member who raised the question or by any other member, refer it to the committee on procedure and conduct of business rules, privileges and implementation of assurances, for report.
- 50. Examination of the question by the Committee.---The Committee shall examine every question referred to it and determine with reference to the fact of each case whether a breach of privilege is involved and, if so the nature of the breach and the circumstances leading to it, and make such recommendations as it may deem fit.
- a question of privilege has been referred to it, and from time to time thereafter, until a report is made within the time fixed by the Tehsil Council. Where the Tehsil Council has not fixed any time for the presentation of the report, the report shall, if the Tehsil Council is in session, be presented to the Tehsil Council, within one month of the date on which reference to the Committee was made, or if the Tehsil Council is not in session, at the commencement of its next session. The Tehsil Council may, at any time, on a motion being made, direct that the time for the presentation of the report by the

Committee be extended to a date specified in the motion.

- (2) Report of the Committee shall be signed by its chairman on behalf of the Committee.
- (3) After the report has been presented, any member may move that the report be taken into consideration whereupon the Presiding Officer may put the question to the Tehsil Council.
- 52. Consideration of the report.—After the motion, made under sub-paragraph (3) of paragraph 51, is agreed to, any member may, after giving one day's notice, move that the Tehsil Council agrees with the recommendation or disagrees, or agrees with amendments, contained in the report.
- 53. Priority for consideration of report of the Committee.—A motion that the report of the committee be taken into consideration shall be accorded the priority assigned to a matter of privilege and when a date has already been fixed for consideration of the report, it shall be given priority as a matter of privilege on the day so appointed.
- 54. Intimation to Presiding Officer of detention of a member.—When a member is detained under any executive order, the executive authority shall immediately intimate such fact to the Presiding Officer, indicating the reasons for the detention of the member.
- 55. Intimation to Presiding Officer on release of a member.—When a member detained under paragraph 54 is released such fact shall also be intimated to the Presiding Officer by the authority concerned.
- 56. Treatment of communications regarding detention and release.—As soon as may be, the Presiding Officer shall, after he has received communication referred to in paragraph 52 or paragraph 54 read it out in the Tehsil Council if in session, or if the Tehsil Council is not in session, direct that it may circulated for information of the members.
- 57. Production of member in custody for a sitting of the Tehsil Council.---(1) The Presiding Officer, on the written request of the member in detention in terms of paragraph 53, may, if deemed appropriate, summon the member in detention to attend a sitting or sittings of the Tehsil Council.
- (2) On a production order, signed by the Secretary, addressed to the District Administration, Government or such authority shall cause the member in custody to be produced before the Presiding Officer, who shall, after conclusion of the sitting of the Tehsil Council, deliver the member into the custody of the authority who produced him.

#### <u>Chapter-XI</u> Adjournment Motions

- 58. Adjournment motions and method of giving notice, etc.---(1) A motion for an adjournment of the business of the Tehsil Council for the purpose of discussing a definite matter of urgent public importance may be made with approval of Presiding Officer.
- (2) Notice of a motion for an adjournment shall be given in writing in triplicate to the Secretary, not less than one hour before the commencement of the

sitting in which it is proposed to be moved, and the Secretary shall, thereupon, bring the notice to the knowledge of Presiding Officer and the Chairman.

- (3) The right to move for an adjournment of the business of the Tehsil Council shall be subject to the following restrictions, namely:
  - (a) not more than one such motion shall be made on any one day;
  - (b) motion shall relate to a single specific matter of recent occurrence;
  - (c) the motion shall not anticipate a matter for consideration of which a date has been previously appointed;
  - the motion shall not deal with a matter in respect of which a resolution could not be moved or any matter which is subjudice;
  - (e) the motion shall not relate to or deal with a matter of privilege or a hypothetical case; and
  - (f) no motion shall be moved on any day fixed for general discussion on budget.
- 59. Time for asking leave for motion for adjournment.---Leave to make a motion for adjournment shall be asked for after questions and before the list of business is entered upon.
- 60. Procedure to be followed.---(1) After hearing the member asking for leave and the Chairman, if the Presiding Officer is of the opinion that the matter proposed to be discussed is in order, he shall read the statement to the Tehsil Council and ask whether the member has the leave of the Tehsil Council to make the adjournment motion and if objection is taken, he shall request such of the members, as may be in favour of leave, being granted to rise in their seats.
- (2) If less than five percent (05%) of the total membership of the Tehsil Council rises in their seats, the Presiding Officer shall inform the member that he has not the leave of the Tehsil Council.
- (3) If not less than five percent (05%) of the total membership of the Tehsil Council, so rise, the Presiding Officer shall announce that leave is granted and the motion shall be taken up as the last item for discussion for not more than one hour within two days after the leave is granted.
- 61. Time limit for speeches.---A speech during the debate on a motion for adjournment shall not exceed ten minutes in duration; provided that the mover and the Chairman may speak for thirty minutes each.

#### <u>Chapter-XII</u> Making of Bye-Laws

62. Notice of motion by members for leave to propose bye-laws.---Any member, desiring to move for leave to propose bye-laws on the subjects within the approval of the Tehsil Council, shall give seven days' notice of his intention and shall, together with his notice, submit a copy of the bye-laws and a statement of objects and reasons.

- Notice of motion by Chairman to propose bye-laws .-- (1) The Chairman or a member authorized by him in this behalf may move for leave to propose bye-laws on the subjects within the approval of the Tehsil Council after giving to the Secretary a written notice of his intention and shall provide a copy of the bye-laws together with a statement of objects and reasons.
- When the item is called, the member or, as the case may be, Chairman shall forthwith move to introduce the bye-laws and on the motion, being made, the byelaws shall stand introduced without discussion.
- Previous consent of the Chairman .-- If notice is given of a motion to propose bye-laws or to move an amendment which, in the opinion of the Presiding Officer, cannot be introduced or moved save with previous consent of the Chairman, the Presiding Officer shall, as soon as may be, after the receipt of the notice, refer the proposal or the amendment to the Chairman and the notice shall not be placed on the list of business unless the Chairman has indicated to the Presiding Officer the necessary
- Motion after introduction .-- When bye-laws are introduced or on some 65. subsequent occasion, the Chairman or, as the case may be, the member may make one of the following motions, namely:
  - that the bye-laws be taken into consideration by the Tehsil (a) Council either at once; or
  - that the bye-laws be referred to appropriate Standing Committee: (b)
  - Provided that no such motion shall be made unless copies i. of the bye-laws have been made available for three clear days before the day on which the motion is made unless the Presiding Officer, in the exercise of his power to suspend this rule, allows the motion to be made.
- Person by whom motions in respect of proposal may be made .--- No motion 66. that a proposal on bye-laws be taken into consideration or be approved or may be referred to the Standing Committee shall be made by any member other than the member-in-charge of the bye-laws.

Explanation: For the purpose of this paragraph "member-in-charge of the proposal" means any member acting on behalf of the Chairman.

- Quorum.--The quorum of a Standing Committee shall be fixed in the motion for reference to the Standing Committee and may be varied, if necessary by the order of the Tehsil Council.
- Vacancy on Standing Committee.—Any vacancy, which occurs on a Standing Committee through death, resignation, absence, inability to attend to duty or otherwise, shall be reported to the Presiding Officer. If the Tehsil Council is in session, the vacancy may be filled by the Tehsil Council, but if it be not in session, or if the matter is, in the opinion of Presiding Officer, urgent, he may appoint a member to fill the vacancy.
- Chairperson of Standing Committee .--- (1) The Standing Committee shall 69. elect its chairperson and in his absence at any meeting may choose any other member present to act as chairperson of the committee for that meeting.

- (2) The Chairperson shall have a casting vote in the case of equality of votes.
- 70. Secretary of Standing Committee.---Unless decided otherwise by the Tehsil Council, the Secretary of the Tehsil Council shall be ex-officio Secretary of all Standing Committees. He shall send notices of the meetings of Standing Committees and shall arrange for the conduct of all correspondence connected with their business.
- 71. Meeting and proceedings of Standing Committee.---(1) The meeting of a Standing Committee shall be held on such date, time and place as the Chairperson of the Standing Committee may fix.
- (2) A Standing Committee may solicit expert opinion and hear representatives of any special interest affected by the measures before it.
- (3) The procedure regarding debate and amendments in a Standing Committee shall be the same as that of the Tehsil Council, except that a member may, with permission of its Chairperson speak more than once on the same question but no dilatory motion shall be allowed.
- 72. Procedure of Standing Committee.- A Standing Committee shall have power to make procedure for conduct of business.
- 73. Report of Standing Committee.---(1) On receipt of reference from the Tehsil Council, the Standing Committee shall meet, from time to time, for consideration of the bye-laws and shall make a report thereon within one month or within the time fixed by the Tehsil Council, whichever is earlier; provided that the Tehsil Council may, at any time on a motion being made, direct that the time for making of report be extended to a date specified in the motion.
- (2) The report shall ordinarily be signed by all members of the committee, but the signature of its Chairperson will be sufficient authentication thereof, and if any member is not able to sign the report, a note shall be added to the report, giving reasons why such member could not sign it. If any member desires to record a note of dissent on any point, he must sign the report stating that he does so subject to his note of dissent and must hand over his note within such time as may be fixed by the chairperson.
- (3) The Presiding Officer shall expunge such words, phrases, expressions or parts of the report or any note of dissent if they are, in his opinion, un-parliamentary or otherwise inappropriate.
- 74. Presentation, printing and publication of report.---(1) The report of the Standing Committee, alongwith note of dissent, if any, shall be presented to the Tehsil Council by the member-in-charge.
- (2) The Secretary shall cause every report of a Standing Committee, together with the note of dissent, if any, to be printed and a copy thereof shall be made available for the use of every member. The report and the bylaws shall be notified.
- 75. Procedure after presentation of report.---After presentation of the final report of a Standing Committee on bye-laws, the member-in-charge may move that the proposal as reported by the Standing Committee be-
  - (a) taken into consideration; or

- (b) re-committed to the same Standing Committee for further consideration; or
- (c) re-circulated for the purpose of obtaining opinion thereon.
- 76. Moving of amendments.---When a motion that bye-laws be taken into consideration has been carried, any member may move an amendment in the bye-laws.
- 77. Rules as to amendments.---(1) An amendment shall be relevant to the subject matter of the bye-laws and shall not be worded in such a way as to make the bye-laws or any part thereof unintelligible or ungrammatical.
- (2) The Presiding Officer shall determine the clause in which an amendment shall be moved.
- (3) The Presiding Officer may refuse to propose an amendment which is, in his opinion, frivolous or meaningless.
- 78. Passing of bye-laws.---(1) When a motion that proposed bye-laws be taken into consideration has been carried and the bye-laws have been considered clause by clause and no amendment of the bye-laws is made, the member-in-charge may at once move that the bye-laws be approved.
- (2) If amendments have been made in the bye-laws, the Presiding Officer on his own motion may, and on the request of any member, shall direct that the bye-laws be examined with a view to report what amendments of a formal or consequential character shall be made in the bye-laws as a matter of drafting by a committee, consisting of the chairman Standing Committee on the Tehsil Office to which the bye-laws relate, the member who introduced the bye-laws, and members nominated by the Presiding Officer and such report shall be presented within such period as the Tehsil Council may direct.
- (3) When the report has been presented and the decision of the Tehsil Council, on the amendments proposed, has been made, the member-in- charge may, at once, move that the bye-laws be approved.
- 79. Scope of debate on the motion for approval of bye-laws.-The discussion on a motion that the bye-laws be approved shall be confined to arguments of a general character either in support or for rejection of the bye-laws.
- 80. Withdrawal and rejection of bye-laws.---(1) The member-in-charge of bye-laws may, at any stage, move for leave to withdraw the bye-laws, and if such leave is granted, no further motion may be made with reference to the bye-laws.
- (2) Where any of the following motions made by the member-in- charge in regard to a proposal of bye-laws is rejected by the Tehsil Council, no further motion shall be made with reference to the bye-laws within a period of three months from the date of rejection-
  - (a) that leave be granted to introduce the bye-laws;
  - (b) that the by-laws be referred to the appropriate Standing Committee;
  - (c) that the bye-laws be taken into consideration;

- (d) that the bye-laws as reported by the Standing Committee be taken into consideration; and
- (e) that the bye-laws or, as the case may be, an amendment thereof, be passed.
- 81. Correction of patent errors.---When bye-laws have been passed by the Tehsil Council, the Presiding Officer shall have the power to correct patent errors and make such other changes in the bye-laws as are consequential on the amendments which are accepted by the Tehsil Council.
- **82.** Authentication and notification of bye-laws.---A copy of the bye-laws, as approved by the Tehsil Council, shall be signed by the Presiding Officer and shall immediately cause it to be notified.

#### <u>Chapter-XIII</u> <u>Petitions to the Tehsil Council</u>

- 83. Presentation and form of petition to the Tehsil Council.---(1) Any person may present or submit a petition, relating to business under consideration, in the Tehsil Council or any of its committees.
- (2) Every petition, signed by the petitioner, shall be couched in respectful and temperate language, addressed to the Tehsil Council, concluded with a prayer, reciting the definite object of the petitioner with having no letter, affidavit, appendix or other documents as annexure.
- (3) Any such petition may be presented through a member, or be forwarded to the Secretary. In latter case, the fact shall be reported by him to the Tehsil Council and no debate shall be permitted on the making of such report.
- (4) A member, presenting a petition, shall confine himself to a statement in the following form:

"I present a petition signed by......petitioner regarding......" and no debate shall be permitted on this statement.

- 84. Nomination of committee on petitions.—The Presiding Officer shall constitute a committee on petitions, which shall consist of two members and a chairman nominated by him.
- 85. Reference to a committee.—Every petition, after presentation by a member or reported by the Secretary, as the case may be, shall be referred to a committee, constituted for the purpose under that bye-laws.
- 86. Examination and report by committee.---(1) The committee shall examine every petition referred to it, and shall report to the Tehsil Council, stating the subject-matter of the petition, the number of persons by whom it is signed and whether it is relevant to the business under consideration. If the petition is relevant, the committee may in its discretion, direct that the petition or its summary be circulated as a paper pertaining to the business to which it relates.

(2) The report of the committee shall be signed and presented to the Tehsil Council by its chairman.

#### Chapter-XIV Resolutions

- 87. Right to move resolution.---Subject to the provisions of these bye-laws, any member may move a resolution, relating to a matter of general interest, at the tehsil level.
- 88. Notice of resolution.---(1) A member, who wishes to move a resolution, shall give seven days' notice of his intention to do so and shall submit, together with the notice, a copy of the resolution, which he intends to move.
- (2) The Chairman, if he wishes to move a resolution, shall give three days' notice of his intention to do so and shall submit, together, with the notice a copy of the resolution, which he intends to move.
- 89. Form and contents of resolution.---(1) A resolution shall be in the form of declaration of opinion by the Tehsil Council or specific recommendation.
- (2) It shall relate to a matter which is primarily the concern of Tehsil Local Government or to a matter in which Tehsil Local Government has substantial financial interest:

Provided that a resolution seeking to communicate the views of the Tehsil Council to the Government, District Administration, in a matter which is not primarily the concern of Tehsil Local Government, shall be admissible.

- (3) It shall be clearly and precisely expressed and shall raise substantially one definite issue.
- (4) It shall not contain arguments, inferences, ironical expressions or defamatory statements, nor shall it refer to the conduct or character of a person, except in his official or public capacity.
- (5) It shall not relate to matters under adjudication in Courts or consideration of tribunals or commissions.
- 90. Admissibility of resolution.---(1) The Presiding Officer shall decide admissibility of a resolution and disallow any resolution, which in his opinion, is in contravention of these bye-laws.
- (2) The Secretary shall give intimation to the member that his resolution has been admitted or disallowed for a specific reason, as the case may be.
- 91. Moving and withdrawal of resolutions.---(1) A member, in whose name a resolution stands in the list of business, shall, when called upon, either withdraw or move the resolution, in which case he shall commence his speech by a formal motion in the terms, appearing in the list of business.
- (2) If the member, when called, is absent or fails to move a resolution, the resolution, standing in his name, shall be deemed to have been withdrawn.

- 92. Amendment of a resolution.---(1) After a resolution has been moved, any member may move an amendment to the resolution, through a notice given one clear day, before the day on which it is moved.
- (2) The Secretary shall, if time permits, cause every amendment to be printed and a copy thereof to be made available for the use of every member.
- 93. Withdrawal of resolution or amendment after being moved.---A member, who has moved a resolution or an amendment to a resolution, shall not withdraw the resolution or the amendment, except by leave of the Tehsil Council.
- 94. Repetition of a resolution.---When a resolution has been moved and the decision of the Tehsil Council given on it, or when a resolution has been withdrawn, no resolution or amendment raising substantially the same question shall be moved within a period of three months.
- 95. Time limit for speeches.---Save with the permission of Presiding Officer, a speech on a resolution shall not exceed ten minutes, except that the mover of a resolution when moving it, and the Chairman, may speak for twenty minutes each.
- **96.** Scope of discussion.---The discussion on a resolution shall be strictly limited to the subject matter of the resolution.
- 97. Copy to the Assistant Commissioner.---(1) A copy of every resolution, which has been passed by the Tehsil Council, shall be forwarded to the Assistant Commissioner for follow up.
- (2) Any such resolution shall have effect only as a recommendation for reddressal.

#### <u>Chapter-XV</u> Procedure in Financial Matters

- **98. Budgets.---(1)** The Assistant Commissioner shall obtain approval of the Chairman Tehsil Local Government for the date for presentation of the annual and supplementary budgets and communicate such orders to the Secretary of the Tehsil Council for appropriate action in accordance with the Act.
- (2) On receipt of a motion, proposing a cut in the demand or supplementary demand for grant of funds, the concerned district officer shall examine the points raised in the motion, or any further points likely to be raised, and prepare a brief for the use of the Chairman.
- (3) The budget shall be presented to the Tehsil Council on such day and at such time as the Chairman may appoint.
- (4) The budget shall not be referred to a committee and no other motion shall be made with reference to it, except as provided in the provisions contained in this Chapter.
- 99. Demands for grants.---(1) No demand for grant shall be made, except on the recommendation of the Chairman.
- (2) A separate demand shall be made in respect of the grant proposed for each tehsil office.

- (3) Each demand shall contain a statement of the total grant proposed and statement of the detailed estimate under each grant divided into items.
- 100. Presentation of the budget .--- The budget shall be presented by the Chairman.
- 101. Budget not to be discussed on presentation.---The only proceeding with reference to the budget on the day which the budget is presented shall be the speech of the Chairman when presenting it.
- 102. Stages of discussion of the budget.---The Tehsil Council shall deal the budget in the following stages:
  - (a) general discussion on the budget;
  - (b) discussion on appropriations (in respect of charged expenditure);
  - (c) discussion and voting on demands for grants (in respect of expenditure other than charged expenditure), including voting on motions for reduction, if any.
- 103. Allotment of days.---The Presiding Officer shall, in consultation with Chairman allot days for different stages of budget, referred to in Paragraph 107; provided that at least two days shall elapse between the day the budget is presented and the first day allotted for general discussion on the budget; provided further that not less than three days shall be allotted for the general discussion.
- 104. General discussion on the budget.---(1) On the days allotted for general discussion, the Tehsil Council may discuss the budget as a whole or any question of principle involved therein, but no motion shall be moved at this stage nor shall the budget be submitted to the vote of the Tehsil Council.
- (2) The Chairman shall have a general right of reply at the end of the discussion.
- 105. Cut-motions.---A member may move a motion to reduce the amount of a demand or omit or reduce an item in a demand.
- 106. Conditions for admissibility of cut-motions.---Every cut motion shall satisfy the following conditions of admissibility, if it shall-
  - (a) relate to one demand only;
  - (b) not seek to increase a grant or alter the destination of a grant;
  - (c) not relate to charged expenditure;
  - (d) be clearly expressed but without arguments, inferences, imputations or defamatory statements;
  - (e) be confined to one specific matter stated in precise terms; (g) it shall not reflect on the character or conduct of any person; and
  - (f) not raise a question of privilege.

- 107. Presiding Officer to decide admissibility of cut-motions.---The Presiding Officer, in consultation with Chairman, shall decide whether a cut-motion is or is not admissible and may disallow any cut-motion if, in his opinion, it is an abuse of the right of moving cut motions or is calculated to obstruct or prejudicially affect the procedure of the Tehsil Council.
- 108. Notice of cut-motion.---Notice of a cut-motion shall be given one clear day before the day on which the demand is taken up for consideration.
- 109. Voting on demands for grants.---(1) Each demand for grant, referred to in Paragraph 115 shall be discussed separately.
- (2) Before a question is put in respect of a demand for grant, all cut-motions in respect of that demand shall be discussed and voted upon.
- (3) When several cut-motions, relating to the same demand, are tabled they shall be discussed in the order in which the heads to which they relate appear in the budget.
- (4) On the last day of the days, allotted under Paragraph 108, for the stages referred to in Paragraph 115, at the time when the meeting is to terminate the Presiding Officer, shall forthwith put every question necessary to dispose of all the out-standing matters in connection with demands for grants.
- 110. Schedule of authorized expenditure.---The schedule of authorized expenditure, when authenticated under sub-section (4) of section 35 of the Act, shall be laid before the Tehsil Council, but shall not be open to discussion or vote thereon.
- 111. Procedure for dealing with supplementary and excess demands.---The procedure for dealing with supplementary estimates of expenditure and excess demands shall, as for as possible, be the same as prescribed for the budget.

### Chapter-XVI COMMITTEES

- 112. Committees of the Tehsil Council.---(1) In addition to the Standing Committees, mentioned in sections B, C, D, E and F of this part, there shall be a committee of the Tehsil Council as referred in section 25 Act for each Tehsil Office.
- (2) Each committee shall deal with the functions, assigned to the office concerned under the Rules of Business of the Tehsil Local Government or any other matter referred to it by the Tehsil Council.
- (3) Whenever there is any change in the composition of the Tehsil Offices or their nomenclature, the Presiding Officer shall issue suitable direction with regard to the re-allocation of the existing Standing Committees and committees or, as the case may be, the modification in their nomenclature and election of the new Standing Committees and committees.
- 113. Reference to Standing Committee and committee.—Except as otherwise provided in these bye-laws, the Tehsil Council may, on a motion made by a member, refer to the Standing Committee and committee any subject or matter with which it is concerned and the Standing Committee and committee shall study such subject or matter with a view to recommend a course of action to the Tehsil Council.

- 114. Composition.---(1) Each committee shall consist of not more than five members, who shall be elected by the Tehsil Council. The election shall be held, as far as possible, in accordance with the procedure agreed to by the leaders of the parties in the Tehsil Council, failing which by non-transferable vote.
  - (2) Each committee shall elect one of the members as its chairperson.
- (3) If the chairperson is not present at any sitting, the committee shall choose one of its members to act as chairperson for that sitting.
- (4) The member, on whose motion any subject or matter was referred to the committee, may attend the meetings of the committee, but shall not vote unless he is a member of the committee.
- (5) The officer-in-charge of the Tehsil Office or an officer nominated by him in this behalf, shall also attend the meetings of the committee for expert opinion.
- 115. Functions.---(1) A committee shall examine the subject or matter referred to it by the Tehsil Council and shall submit its reports to the Tehsil Council with recommendations, including a definite course of action, as it may deem necessary.
- (2) In case of bye-laws, the committee may propose amendments which be shown in its report alongwith the original provisions; but the committee shall have no power of preventing the bye-laws from coming to the Tehsil Council.
- (3) If a committee does not present its report within the period prescribed, or the time allowed, the bye-laws, subject or matter referred to it, may be considered by the Tehsil Council, without waiting for the report, upon a motion by any member or by the Chairman.
- 116. Finance Committee.---(1) There shall be a Finance Committee for duration of the Tehsil Council.
- (2) The Finance Committee shall consist of the chairperson and four other members by the Tehsil Council from amongst its members.
  - (3) The Presiding Officer shall be the chairperson of the Finance Committee.
- (4) A member may resign his membership of the Finance Committee by writing under his hand addressed to the Presiding Officer.
  - (5) Casual vacancies in the committee shall be filled by election.
- 117. Functions of the Finance Committee.---The Finance Committee shall be responsible for-
  - (a) the examination of tax and budget proposals, re-appropriations and supplementary grants;
  - (b) the preparation of budget and supplementary estimates and demands for excess relating to the Tehsil Council and its office; and
  - (c) all financial matters relating to expenditure of the Tehsil Council and its office within authorized appropriation.

- 118. Procedure.---The Finance Committee shall regulate its procedure in a manner as it may specify.
- 119. Tehsil Accounts Committee.---(1) The Tehsil Accounts Committee shall consist of seven members to be elected by the Tehsil Council from amongst its members.
  - (2) Leader of the opposition in the Tehsil Council shall be its chairperson.
- 120. Functions of the Tehsil Account Committee.---(1) The Tehsil Accounts Committee shall examine the accounts, showing local appropriation of sums granted by the Tehsil Council for the expenditure of Tehsil Government, the report of the Auditor-General of Pakistan and such other matters as the Tehsil Council or Chairman may refer to it.
- (2) In scrutinizing the appropriation accounts of Tehsil Government and the reports of the Auditor-General of Pakistan thereon, it shall be the duty of the Tehsil Accounts Committee to satisfy itself,-
  - (a) that the moneys shown in the accounts as having been disbursed were legally available for, and applicable to, the service or purpose to which they have been applied or charged;
  - (b) that the expenditure conforms to the authority which governs it; and
  - (c) that every re-appropriation has been made in accordance with rules prescribed in that behalf.
- (3) It shall also be the duty of the Tehsil Accounts Committee to examine the statement of accounts showing the income and expenditure of any autonomous, semi-autonomous bodies, institutions, concerns and projects established by Tehsil Local Government, together with the balance sheets and statements of profit and loss accounts prepared under the provisions of rules, regulating the financing of a particular body, institution concern and project and the report of the Auditor- General of Pakistan thereon.
- (4) If any money has been spent on any service during a financial year in excess of the amount, granted by the Tehsil Council for that purpose, the Tehsil Accounts Committee shall examine with reference to the facts of each case the circumstances leading to such an excess and make such recommendations as it may deem fit.
- 121. Report of the Committee.---The report of the committee shall be presented within a period of two months from the date on which reference was made to it by the Tehsil Council unless the Tehsil Council, on a motion being made, directs that the time for the presentation of the report be extended to a date specified in the motion.
- 122. Committee on Conduct of Business.---(1) The Committee on Conduct of Business, shall consist of five members to be elected by the Tehsil Council from amongst its members.
- (2) The Standing Committee shall elect one of its members to be its Chairperson.

#### 123. Functions of the Standing Committee.--- The Standing Committee shall-

- (a) consider matters regarding procedure and conduct of business in the Tehsil Council and recommend such amendments in the byelaws as may be necessary;
- (b) consider and advise on matters relating to library and procurement of books, magazines, journals and reference material for use by members and staff of the Tehsil Council; and
- suggest a procedure to be followed by the Tehsil Council to give effect to its recommendations and decisions.
- 124. Committee on Assurances.---(1) The Committee on Assurances shall consist of five members to be elected by the Tehsil Council.
- (2) The Standing Committee shall elect one of its members to be its Chairperson.

#### 125. Functions of the Standing Committee.--- The Standing Committee shall-

- (a) examine every question of privilege referred to it by the Tehsil Council and determine whether a breach of privilege was involved and, if so, the nature of the breach and the circumstances leading to it, and to make such recommendations as it may deem fit;
- (b) may scrutinize the assurances, promises and undertakings, given by the Chairman, from time to time, on the floor of the Tehsil Council and furnish a detail report for remedial measures to the Tehsil Council; and
- (c) suggest a procedure to be followed by the Tehsil Council to give effect to its recommendations.
- **126.** Committee on Code Of Conduct.---(1) There shall be a Code of Conduct Committee of the Tehsil Council composed of five members nominated by the Presiding Officer for duration of the Tehsil Council.
- (2) The Standing Committee shall elect one of its members as its chairperson.
- 127. Functions of the Standing Committee.---The functions of the Standing Committee shall be-
  - (a) to propose a code of conduct and ethics for the members;
  - (b) oversee the observance of the code of conduct and ethics by the members;
  - (c) to deal with matters relating to the issue of admission cards for galleries; and
  - (d) to exercise supervision over facilities pertaining immunities provided to members;

128. Sitting of Committee.---(1) The chairperson of a committee may determine the agenda and schedule of sittings for the committee but a committee may not sit when the Tehsil Council is in session:

Provided that if the chairperson of the committee is not readily available, the secretary may fix the date and time of a meeting with the consent of the Presiding Officer.

- (2) The sitting of a committee shall ordinarily be held within the precincts of the Tehsil Council.
- (3) On a requisition, made by not less than three members of a committee, the chairperson of the committee shall call a meeting of the committee within seven days from the date of receipt of the requisition.
- (4) The Secretary shall send notices of all meetings to the members of the committee.
- (5) The committee may solicit views of the concerned Tehsil Office on any matter pending consideration in the committee.
  - (6) The quorum, to constitute a sitting of a committee, shall be three.
- (7) Where the sitting of a committee is adjourned on two successive days for want of quorum, the chairperson of the committee shall report the fact to the Presiding Officer.
- (8) If a member remains absent from three or more consecutive sittings of the committee without the permission of its chairperson, a motion may be moved by any member in the Tehsil Council for the discharge of such member from the committee.
- (9) A member may resign his membership of a committee by writing under his hand addressed to the Presiding Officer.
- (10) Casual vacancies in a committee shall be filled, as soon as possible, through the same process as is applicable to its initial constitution.
- (11) Subject to the requirement of a quorum, a committee shall have power to act notwithstanding any vacancy in its membership.
- (12) A member may, with the permission of the chairperson of the committee, speak more than once on a particular point or matter at a sitting of a committee.
- (13) All questions at a sitting of a committee shall be determined by a majority of the members present and voting with the chairperson having casting vote in the event of equality of votes.
- (14) A committee shall have power to require the attendance of persons or the production of papers or records, if such course is considered necessary for the discharge of its duties.
- (15) A committee may summon or allow to appear before it any person having a special interest in relation to any matter under its consideration and may hear expert evidence.

- (16) The Secretary shall maintain record of proceedings of each committee.
- (17) A committee may, if it thinks fit, make a special report on any matter that arises or comes to light in the course of its work which it may consider necessary to bring to the notice of the Presiding Officer or the Tehsil Council.
- (18) Where the Tehsil Council has not fixed any time for the presentation of a report, the report of a committee shall be presented within one month from the date, on which reference was made to it by the Tehsil Council, unless the Tehsil Council on motion being made, directs that the time for presentation of the report be extended to date specified in the motion.
- (19) The Secretary shall, cause a copy of each report of a committee, together with the minutes of dissent, if any, to be made available for the use of every member of the Tehsil Council.
- (20) The report of a committee shall be presented to the Tehsil Council by the chairperson or, in his absence by another member chosen by the committee.
- (21) The Presiding Officer may, on a request being made to him, when the Tehsil Council is not in session, order the printing for circulation of a report of a committee to the members of the Tehsil Council, although it has not been presented to the Tehsil Council. In that case, the report shall be presented to the Tehsil Council during its next session at the first convenient opportunity.
- (22) If any doubt arises on any point of procedure or interpretation of this clause or the provisions in this chapter are silent on a point, the chairperson may refer the point to the Presiding Officer whose decision thereon shall be final.
- (23) Any business pending before a committee shall not lapse by reason only of the prorogation of the Tehsil Council and the committee shall continue to function notwithstanding such prorogation.
- (24) A committee, which is unable to complete its work before the expiration of its term or before the expiration of the term of the Tehsil Council, shall report to the Tehsil Council that the committee has not been able to complete its work. Any preliminary report, memorandum or note that the committee may have prepared or any evidence that the committee may have recorded, shall be made available to the committee succeeding the committee under reference.
- 129. Special Committee.---The Tehsil Council may, by motion, appoint a special committee which shall have such composition and functions as may be specified in the motion.
- 130. Provisions relating to Standing Committees to apply to other committees.---In the absence of special provisions relating to a special committee, the provisions relating to Standing Committees shall apply mutatis mutandis to a special committee.

### <u>Chapter-XVII</u> Reports to be Laid Before the Tehsil Council.

131. Recommendations of Provincial Finance Commission.---Recommendations of the Provincial Finance Commission and its annual report shall be laid before the Tehsil Council.

- 132. Annual and special reports of Local Government Commission.---Annual and special reports of Local Government Commission shall be laid before the Tehsil Council.
- 133. Reports of Auditor-General.---The annual reports of the Auditor-General relating to the accounts of the district when received, shall be laid before the Tehsil Council.
- 134. Discussion, etc., on reports.---(1) After a report is presented to or laid before the Tehsil Council, the Presiding Officer shall fix a date for its discussion. On the day so fixed the Chairman may move that the report be discussed by the Tehsil Council and may briefly explain the salient features of the report.
- (2) The Tehsil Council may, by a resolution, express its opinion or make any observation or recommendation on the report.

#### <u>CHAPTER-XVIII</u> GENERAL RULES OF PROCEDURE

- 135. Want of quorum.---If, when the Tehsil Council is sitting, notice is taken by a member that the number of members prescribed to form a quorum by sub-section (7) of section (79) of the Act is not present, the person presiding shall, unless he is satisfied that such number of members as is required to form the quorum is present, shall count the members present. If less than the required number be present, he shall either adjourn the Tehsil Council till the next meeting day or suspend the meeting till such time the required number of members is present.
- 136. Language of the Tehsil Council.---Unless otherwise decided by the Presiding Officer, all proceedings of the Tehsil Council may be conducted in Urdu, . However, the proceeding of the Tehsil Council shall be recorded in Urdu or English for official use.
- 137. Motion, proposal of question and closure.---(1) A matter, requiring the decision of the Tehsil Council, shall be decided by means of a question put by the Presiding Officer, on a motion moved at a meeting of the Tehsil Council.
- (2) Save as otherwise provided in these bye-laws, a member, who wishes to move a motion, shall give, in the case of a substantive motion, at least three clear days' notice and in the case of an amendment, at least one clear day's notice in writing of his intention to the Secretary.
- (3) A motion or amendment, which requires notice, may be moved only by the member giving notice.
- (4) If a motion or amendment is not moved, it shall be deemed to have been withdrawn.
- (5) A motion or amendment shall not be moved in a form different from that in which it appears on the notice paper, unless the Presiding Officer, in his discretion, permits it to be moved in an altered form.
- (6) A motion or amendment shall not, except with the permission of the Presiding Officer, raise a question substantially identical with one on which the Tehsil Council has given a decision in the same session.

- (7) A motion or amendment shall not anticipate a matter already appointed for consideration of the Tehsil Council, and in determining whether a motion is out of order on the ground of anticipation, the Presiding Officer shall have regard to the probability of the matter anticipated, being brought before the Tehsil Council, within a reasonable time.
- (8) When motion has been moved, the Presiding Officer may propose the question for the consideration of the Tehsil Council, and if a motion embodies two or more separate propositions, those propositions may be proposed as separate questions.
- (9) At any time, after a question on a motion has been proposed from the Presiding Officer and before the voices, both of "Ayes" and "Noes", have been collected, the motion may, with the leave of the Tehsil Council and not otherwise, be withdrawn by the member who moved it.
- (10) No discussion shall be permitted on a request for leave to withdraw a motion except with the leave of the Presiding Officer.
- (11) An amendment may be moved to a question by the member who has given notice of the same.
- (12) An amendment shall be relevant to, and within the scope of the motion, to which it pertains and shall not raise a question which can only be raised by a substantive motion after notice.
- (13) An amendment on a question shall not be inconsistent with a previous decision on the same question given at the same stage of the matter.
- (14) In respect of any motion, the Presiding Officer shall have the power to select one of the identical or substantially identical amendments to be proposed and, if he thinks fit, call upon the member, who has given notice of an amendment, to give such explanation of the object of the amendment as may enable him to form a judgment upon it.
- (15) At any time after a question has been proposed, a member, rising in his seat, may claim to move "that the question be now put", and unless it appears to the Presiding Officer that such motion is an abuse of the bye-laws or an infringement of the rights of the minority, the question "that the question be now put" shall be put forthwith, and decided without amendment or debate.
- (16) When the motion "that the question be now put" has been carried and the question consequent thereon has been decided, any further motion may be made with the consent of Presiding Officer which may be requisite to bring a decision on any question already proposed.
- 138. Procedure on division.---(1) Save as otherwise provided, the vote of the members on any question put by the Presiding Officer, may be taken by voices.
- (2) If voting by voice is challenged, the Presiding Officer shall ask the members, who are in favour of "AYES" to stand and the Secretary shall count the number. After counting of the votes in favour of "AYES", the Presiding Officer shall again ask those members who are in favour of "NOES" to stand and the Secretary shall count them.

- (3) In case of counting, names of the voters shall not be recorded.
- (4) The result of voting by a division shall be announced by the Presiding Officer and shall not be challenged.
- (5) The Presiding Officer shall have the discretion to postpone the division for five minutes to enable members not present in the chamber to return to their places and participate in the voting.
  - (6) A member is not bound to vote.
- (7) A member may not vote on any question, in which he has a direct, immediate and personal pecuniary interest. If he votes on such a question, the vote may, on a substantive motion carried by the Tehsil Council, be disallowed.
- 139. Right of speech and mode of address.---(1) Except as otherwise provided, a member may speak on any question before the Tehsil Council or raise a point of order.
- (2) A member, who desires to speak, shall speak from his place, and unless disabled by sickness or infirmity, shall rise when speaking and shall address the Presiding Officer.
- 140. Procedure when Presiding Officer rises.---Whenever the Chairman rises during a debate, any member, who is then speaking or offering to speak, shall resume his seat.
- 141. Order of speeches.---After the member, who moves the motion, has spoken, other members may speak on the motion in such order, as the Presiding Officer may call upon them.
- 142. Principles of debate.---(1) The subject matter of every speech shall be strictly relevant to the question before the Tehsil Council.
  - (2) A member, while speaking, shall not-
    - (a) reflect upon any person in his personal capacity;
    - (b) utter unreasonable or defamatory words or make use of offensive expressions;
    - (c) refer to a matter of fact on which a judicial decision is pending;
    - speak against or reflect on any determination of the Tehsil Council except when he is moving to rescind the same;
    - (e) make a personal charge against a member; and
    - (f) use his right of speech for the purpose of willfully and persistently obstructing the business of the Tehsil Council.
- 143. Bar on reading.---A member may not read his speech but may refresh his memory by reference to notes:

Provided that the budget speech of the Chairman shall be exempted from this provision.

- 144. Right of reply.---(1) Except in the exercise of a right of reply, no member shall speak more than once on any motion, except with permission of Presiding Officer for the purpose of making a personal explanation.
  - 2) A member, who has moved a motion, may speak again by way of reply.
- 145. Presiding Officer may address the Tehsil Council.---The Presiding Officer may in all cases address the Tehsil Council on matters relating to procedure before putting a question to the vote.
- 146. Code of conduct for members present.- A member while present in the Tehsil Council shall not-
  - (a) cross between the Presiding Officer and a member who is speaking;
  - (b) read any book, newspaper or letter, except in connection with business of the Tehsil Council; and
  - (c) interrupt any member while he is speaking.
- 147. Questions to be asked through Presiding Officer.—When, for the purpose of explanation during discussion, any member has the occasion to ask a question of another member on any matter under consideration of the Tehsil Council, he shall ask the question through the Presiding Officer.
- 148. Points of order and decision thereon.---(1) A point of order shall relate to the interpretation or enforcement of these bye-laws or such provisions of the Act as regulate the business of the Tehsil Council and shall confine to a question which is within the cognizance of the Presiding Officer.
- (2) Any member may, at any time, submit a point of order for decision of Presiding Officer, but in doing so, he shall confine himself to stating the point.
- (3) During division, a member may raise a point of order only on a matter arising out of the division.
- (4) The Presiding Officer shall decide all points of order which may arise and his decision shall be final.
- (5) No discussion or debate shall be allowed on any point of order but the Presiding Officer may, if he thinks fit, hear members before giving his decision.
- (6) A member shall not raise a point of order to ask for information or explain his position or which may be hypothetical.
- 149. Irrelevance or repetition.---The Presiding Officer after having called the attention of the Tehsil Council, to the conduct of a member, who persists in irrelevance or in tedious repetition, either of his own arguments or of the arguments used by other members in debate, may direct him to discontinue his speech.
- **150.** Power to order withdrawal of member or suspend sitting.---(1) The Presiding Officer shall preserve order and have all powers necessary for the purpose of enforcing his decision on all points of order.

- (2) The Presiding Officer may direct any member, whose conduct is, in his opinion, grossly disorderly, to withdraw immediately from the Tehsil Council and any member, so ordered to withdraw, shall do so forthwith and shall absent himself during the remainder of the day.
- (3) The Presiding Officer may, in the case of grave disorder arising in the Tehsil Council, suspend any sitting for a time to be specified by him.
- 151. Strangers and sitting in camera.---(1) The admission to the galleries of the Tehsil Council of visitors and representatives of media during the sittings of the Tehsil Council shall be regulated in accordance with the orders of Presiding Officer.
- (2) The Presiding Officer, whenever he thinks fit, may order visitors or representatives of the media to leave the galleries or order any stranger to be removed.
- (3) On a request, made by the Chairman, the Presiding Officer may, in his discretion, fix a day or part thereof for sitting of the Tehsil Council in camera.
- (4) When the Tehsil Council sits in camera, no stranger shall be permitted to be present in the Chamber, lobby or galleries, except Secretary.
- (5) The Presiding Officer may cause a report of the proceedings of a sitting in camera to be issued in such manner, as he thinks fit, but no other persons shall keep a note or record of any proceedings or decisions of a sitting in camera whether in part or full, or issue any report of, or divulge or purport to describe, such proceedings.
  - 152. Reports of proceedings.---The Secretary shall cause to be prepared a full report of the proceedings of the Tehsil Council at each of its sittings, and shall, as soon as practicable, circulate it in such form and manner as the Presiding Officer may direct.
  - 153. Expunction of words from debates.---(1) If the Presiding Officer is of the opinion that words have been used in debate, which are defamatory, indecent, unparliamentary or un-dignified, he may, in his discretion, order that such words be expunged from proceedings of the Tehsil Council.
  - (2) The portion, so expunged, shall be denoted by asterisk with an explanatory foot note to this effect.
  - 154. Custody of documents and records.-The Secretary shall have the custody of records, documents and papers belonging to the Tehsil Council or any of its committees and he shall not permit any such record, documents or papers to be taken out of the office without the permission, in writing, of the Presiding Officer.
  - 155. Secretary to be ex-officio Secretary of Committees.---The Secretary shall be ex-officio secretary of all the committees of the Tehsil Council and may authorize any officer or subordinate to him to perform such duties as he may direct.
  - 156. Suspension of bye-laws.---Whenever any inconsistency or difficulty arises in the application of these bye-laws, any member may, with the consent of the Presiding Officer, move that any clause may be suspended in its application to a particular motion before the Tehsil Council and if motion is carried, the clause in question shall stand suspended.
  - 157. Residuary powers of the Presiding Officer.---Any matter, arising in connection with the business of the Tehsil Council and its committees, for which no specific provision exists in these bye-laws, shall be decided by the Presiding Officer

and his decision shall be final and all questions relating to the detailed working of these bye-laws shall be regulated in such manner as the Presiding Officer may direct.

### CHAPTER-XIX AMENDMENT OF BYE-LAWS

- 158. Notice of proposal to amend bye-laws.---(1) Not less than seven clear days' notice of a motion for leave to amend the bye-laws shall be given and the notice shall be accompanied by a draft of the amendment proposed.
- (2) The motion shall be set down for such day as the Presiding Officer may direct.
- (3) When the motion is reached, the Presiding Officer shall read out the draft of the amendment proposed and ask whether the member has leave of the Tehsil Council. If objection is taken, the Presiding Officer shall request those members who are in favour of leave being granted, to rise in their seats, and if not less than five percent members so rise, the Presiding Officer shall intimate that the member has the leave of the Tehsil Council. If less than five percent members rise, the Presiding Officer shall inform the member that he has not the leave of the Tehsil Council.
- (4) When a member has the leave of the Tehsil Council to proceed, he shall move that the draft be referred to the committee on conduct of business.
- (5) After a draft has been referred to the committee, the procedure in regard to bye-laws similarly committed, shall be followed, as far as may be, with such variations as the Presiding Officer may consider necessary or convenient.
- (6) When a clause or an amendment to a clause is passed by the Tehsil Council, a copy thereof shall be signed by the Presiding Officer and then it shall come into force at once.

#### CHAPTER-XX REPEAL

- 159. Repeal and saving.---The District Tehsil Council (Procedure and Conduct of Business and Meetings) Bye-laws, 2015, District ----- and the Tehsil Council (Procedure and Conduct of Business and Meetings) Bye-laws, 2015, Tehsil ------ are hereby repealed.
- (2) Notwithstanding the repeal of aforementioned bye-laws, all orders and instructions, issued before commencement of these bye-laws, and not inconsistent to the provisions of these bye-laws, shall be deemed to be valid within the meanings of these bye-laws.
